### **Privacy Notice: Teaching School Hub**

Coventry and Central Warwickshire Teaching School Hub (CCWTSH) works in partnership with UCL (University College London) (ECF & NPQ) and University of Warwick (ITT). We are committed to keeping your information secure and managing it in accordance with our legal responsibilities under data protection law. Under data protection law, individuals have a right to be informed about how organisations use any personal data that they hold about them. We comply with this right by providing privacy notices to individuals where we are processing their personal data.

This privacy notice explains how we collect, store and use personal data about individuals who have booked Courses and Events through the CCWTSH web site and online booking routes, and those who seek to access the services that we provide such as, the ECF (Early Career Framework), AB (Appropriate Body Services), NPQ (National Professional Qualifications), ITT (Initial Teaching Training) and other CPD (Continuing Professional Development).

## What is a Privacy Notice?

This notice is to help you understand **how** and **why** we collect personal information about you and **what** we do with that information. It also explains the decisions that you can make about your own information.

In registering /applying for a place on an event or programme with CCWTSH, you are agreeing to the collection and sharing of personal data in accordance with this privacy notice.

## What is Personal Information?

Personal information relates to a living individual who can be identified from that information. Identification can be by the information alone or in conjunction with any other information in the data controller's possession or likely to come into such possession.

'Special category' personal information reveals racial or ethnic origin, political opinions, religious or philosophical beliefs, or trade union membership, and the processing of genetic data, biometric data for the purpose of uniquely identifying a natural person, data concerning health or data concerning a natural person's sex life or sexual orientation.

## Why do we collect information?

Personal data will be processed to allow CCWTSH to:

- Book individuals on to events & courses
- Correspond with individuals about events & courses
- Ensure access for individuals at events
- Ensure food safety
- Provide registers for events
- Provide trainers, facilitators and providers with information about events & courses
- Send invoices for events and bookings
- Monitor performance of each provider
- Deliver Quality Assurance (QA) of each provider
- Evaluate the effectiveness of the CPD and events. The evaluation will directly inform the review of performance and quality of delivery by providers, any improvements to CCWTSH programme policy and delivery and the outcomes for future participants.
- Understand the characteristics of who accesses, completes and benefits from the services we offer and in what way, and who does not
- Understand the outcomes for participants, schools and pupils and any opportunities to improve these outcomes.
- Provide anonymised reports of attendance at CPD/events over time
- Complete anonymised reports for impact of CPD/events for CCWTSH, Teaching Schools Council, UCL, University of Warwick and the Department for Education
- Monitor participant engagement with courses that we operate
- Provide Appropriate Body Services where these services have been requested

## The personal data we collect, hold and share:

- Title
- Name
- Email address
- Role
- Employing organisation
- Special requirements (such as accessibility needs)
- Dietary requirements
- CPD evaluations
- Workshop/course preferences
- Billing contact information
- TRN (Teacher Reference Number)
- Attendance and Engagement Data
- **For AB services only:** ECT home address & contact details
- **For AB services only:** ECT assessments & progress reviews
- **For facilitators and Induction Officers only:** DBS number

## Who else do we share this information with?

We routinely share participant's information with:

- Coordinators and facilitators at our delivery partner schools and organisations
- UCL
- University of Warwick
- Teaching Schools Council
- The Department for Education
- **AB Services only:** TRA (Teacher Regulation Agency) & Induction Advisors

## How will they use this information?

- To coordinate and deliver training sessions
- **AB Services only :** To provide support and quality assure Induction
- To evaluate the provision and effectiveness of CCWTSH

## The lawful basis on which we use this information

We only collect and use personal data when the law allows us to. Most commonly, we process it where:

- We need to complete our contractual obligations
- To meet our public duty interests and submit information to government departments

Less commonly, we may also process your personal data in situations where:

- We have obtained consent to use it in a certain way
- We need to protect the individual's vital interests (or someone else's interests)

Where we have obtained consent to use personal data, this consent can be withdrawn at any time. We will make this clear when we ask for consent, and explain how consent can be withdrawn.

Some of the reasons listed above for collecting personal data overlap, and there may be several grounds which justify our use of this data.

### **Requesting access to your personal data**

Under data protection legislation, you have the right to request access to information about them that we hold. To make a request for your personal information, contact **Rebecca Wheeler, Teaching School Hub Director**, in the first instance.

You also have the right to:

- object to processing of personal data that is likely to cause, or is causing, damage or distress
- prevent processing for the purpose of direct marketing
- object to decisions being taken by automated means
- in certain circumstances, have inaccurate personal data rectified, blocked, erased or destroyed
- claim compensation for damages by a breach of the Data Protection regulations

If you have a concern or complaint about the way we are collecting or using your personal data, you should raise your concern with us in the first instance or our Data protection Officer at Warwickshire County Council (details below) or directly to the Information Commissioner's Office at <https://ico.org.uk/concerns/>
